# Keynote Speaker—Nicole Roundy, Paralympian

Nicole's message of victory over challenges makes her a sought after speaker. Her personal stories of hardship and triumph are known to unite and inspire audiences. As a child, Nicole was ambitious, energetic and outgoing. She spent much of her childhood outdoors kicking soccer balls and exploring the outdoors with her two older brothers. Then at 8 years old, she was diagnosed with Osteogenic Sarcoma, a rare form of bone cancer. Later that year she lost her right leg above-the-knee and continued aggressive chemo therapy treatment. As any individual touched by cancer, Nicole's life took a dramatic turn. Following the 2002 Salt Lake City Winter Olympic games, Nicole stepped onto a ski slope for the first time. The beauty, adrenaline and excitement of three-track skiing captivated her, but something was missing. Deemed "impossible" due to a lack of prosthetic knee technology, Nicole found her passion in snowboarding. In 2006 she became the first above-knee amputee, male or female, to compete in adaptive snowboarding. Her accomplishments spearheaded global demand for prosthetic knee technology and played a fundamental role in the introduction of snowboarding to the Paralympic roster. Nicole represented the United States in the 2014 Paralympic Winter Games and is a 17X World Cup Medalist. She is consistently ranked as one of the best adaptive snowboarders in the world. Not only is Nicole an amazing athlete, but she is an accomplished motivational speaker and holds a degree in Business Management. Nicole is an advocate for The Challenged Athletes Foundation, The National Ability Center and childhood cancer research.

#### JoD'Ann Bates,CMC Highland City Recorder





# Utah State Archives Spotlight On.....

# Michele Jolley Richfield City Recorder

The Utah State Archives Recently had the privilege of visiting Michele Jolly, City Recorder, and Mayor David Ogden of Richfield City.

Michele has been the City Recorder for 21 years. During her time she has implemented many programs and processes to help to ensure the proper care of the city's records. For example, she conducted a complete inventory of the city's records to document record types and storage location. She also documented the retention for each record, and created retention schedules for records which did not have one.

To better protect historical records, Michele moved documents that were housed in multiple safes around the city to one safe in the city building. This effort provides additional security of the records as well as convenience to those who need to access the records.

Michele implemented an annual records management training program to educate city employees about government records. She trains department heads each year on their record retention schedules, and then the department heads are then responsible for training employees in their office.

Michele has always been concerned about knowing who had what records and where, especially with historical records. As she put it, "Permanent records are not replaceable". The active management of historic records has paid off. Richfield City has a nearly complete set of meeting



minutes, running from 1880-present.

Michele's great care of city records is also evident in her willingness to collaborate with the Utah State Archives to microfilm the city's historic records—an initiative that Mayor Ogden, lover of history and Richfield himself, strongly supports. This collaboration will create a preservation copy of the city's historical records (meeting minutes, ordinances, resolutions) that will further ensure future access to the city's rich history.
