
UMCA Region Redistricting

The UMCA Board has been discussing redistricting the regions over the past year. A few of the regions are so large, that many cities are not able to participate due to the long distances to the meetings. It was decided these regions would be split. Some regions have stayed the same, some have been changed, and others have been created.

The changes are as follows:

Central Utah Regional Association (CURA), South Central Utah Regional Association (SCURA) and Southwest Regional Municipal Clerks Association (SWRCA) have been given boundary revisions.

Millard County Recorders Association (MCRA), Carbon, Emery Recorders Association (CERA) and Central Region Recorders Association (WGBP) are newly created regions.



A new map has been made incorporating these changes as seen here. The map can also be found on the UMCA website.

The new Regional Associations have each been assigned an Acting President who will convene a meeting in December, 2014 to elect 2015 presidencies.

The 2015 presidencies of these newly created regions will draw up bylaws to be adopted by their members.




