Certified Municipal Clerk (CMC)

The <u>CMC program</u> is designed to enhance the job performance of the Clerk in small and large municipalities. To earn the CMC designation, a Municipal Clerk must attend extensive education programs. The CMC program prepares the applicants to meet the challenges of the complex role of the Municipal Clerk by providing them with quality education in partnership with institutions of higher learning, as well as State / Provincial / National Associations. The CMC program has been assisting clerks to excel since 1970.

Master Municipal Clerk (MMC)

The <u>MMC program</u> is one of the two professional designations granted by IIMC. The MMC program is an advanced continuing education program that prepares participants to perform complex municipal duties. The program has an extensive and rigorous educational component and a professional and social contribution component. The MMC applicant must demonstrate that they have actively pursued education and professional activities.

A Message from Education Director, Denise Woods

Our Board and Education Committee are gearing up to bring you more outstanding Institute, Academy, and Annual Conference classes this coming year.

We work tirelessly to ensure that the classes offered to you meet the guidelines and standards established by IIMC and try to maximize the amount of certification points available to you by attending.

Both the CMC and MMC designations require 60 points in the Education Category. The most efficient way to earn those points are by attending Institute and Academy. At Institute and Academy, you can earn 1 point per 2 in-class hours, with a learning assessment submitted. If you attend the UMCA Annual Conference or Recorder's Day the education points are earned at a rate of 1 point per 4 in-class hours, with a learning assessment submitted.

The classes at Institute and Academy are more technical or the "nuts and bolts" type of sessions. The annual conference will have more professional and personal development sessions along with a few technical classes offered in the break-out sessions.

We appreciate you, your participation, and sharing your ideas and thoughts with us so we are able to bring you the best professional and personal development courses possible.

I wish you all the best in the New Year and look forward to seeing you soon – Institute & Academy is just around the corner, April 3 – 7, 2023 in Cedar City.


