# Utah Municipal Clerks Association State Certification

The Utah Municipal Clerks Association State Certification program is designed to prepare clerks and recorders in the state of Utah for the challenges of the complex role of a municipal clerk. The UMCA State Certification is a rigorous designation earned by completing various educational and professional development opportunities. An affordable option compared to a CMC or MMC designation, obtaining the UMCA state certification is a great option for clerks looking to add to their resumes. This certification program is available through UMCAs partnership with Southern Utah University (SUU). Click on the link for Information on the State Certification program on the SUU website.

#### Certified Municipal Clerk (CMC)

The <u>CMC program</u> is designed to enhance the job performance of the Clerks in small and large municipalities. To earn the CMC designation, a Municipal Clerk must attend extensive education programs. The CMC program prepares the applicants to meet the challenges of the complex role of the Municipal Clerk by providing them with quality education in partnership with institutions of higher learning, as well as State / Provincial / National Associations. The CMC program has been assisting clerks to excel since 1970.

#### Master Municipal Clerk (MMC)

The MMC program is one of the two professional designations granted by IIMC. The MMC program is an advanced continuing education program that prepares participants to perform complex municipal duties. The program has an extensive and rigorous educational component and a professional and social contribution component. The MMC applicant must demonstrate that they have actively pursued education and professional activities.
