What is an Athenian Dialogue? By Katie Hansen – West Point City

Athenian Dialogues are a great way to earn additional points toward your CMC, MMC, or State Certification. Tanner Vario, our Athenian Dialogue Facilitator, has described it as a "book club on steroids", where you read a selected book in advance and then come together with your peers to discuss the book and get more out of it. Athenian dialogues are a fun way to get to know your peers on a deeper level with the moderator's help as they guide conversations and activities related to whatever book you read.

When I first learned about Athenian Dialogues and IIMC's Athenian Leadership Society I wanted to be a part of this learning experience. I also wanted to help get Utah clerks more aware and involved in participating in the dialogue sessions being offered, not only because of the valuable knowledge learned and shared, but because each completed session qualifies for 3 Education Points towards either CMC or MMC certifications. We have been extremely lucky because our Institute Director, Tanner Vario, took on this challenge and became an IIMC-approved Athenian Dialogue Facilitator.

What you do is read the assigned book and then at the dialogue session with the guidance of the facilitator, the group discusses things like leadership, character, culture, and other principles contained in the book. I have learned so much from the different authors, but I have to say that I have learned more from listening to and discussing the different points of view of my fellow clerks.

UPDATED - The Primary Election has been moved to **Tuesday, September 5** and the General Election is now on **Tuesday, November 21**

UPDATED – Ballots are due for the Primary Election *on or before* <u>September 5, 2023,</u> or for the General Election *post marked before* <u>November 21, 2023.</u> If a vote by mail ballot is delivered in the mail, it must be postmarked or otherwise marked as "received" by the post office on or before this date. HB 2001

UPDATED - The deadlines for the Candidate Profiles for the State website at <u>vote.utah.gov</u> have been adjusted and are as follows: Primary Election: **July 25** and General Election: **September 22**

UPDATED - Campaign Financial Disclosures are due by <u>5:00 p.m</u>. on the due date. Campaign finance statements should include all contributions received and expenditures made up to and including 5 days before the campaign finance statement is due.


